In section 17.31 of the ordinance, the duties and powers of the Commission need to be well defined and have standards by which we are to review with consistency. Commissioners were asked to review the existing rules and bring their ideas and suggestions to the next regular meeting to address the new duties and standards that will be needed. Reviewing the Secretary of Interior Standards might help the committee clarify and make consistent these new duties and rules.

Some of these goals are, but not limited to: Expand Boundaries, Define Architecture, Change Ordinance to include submission of permits to be reviewed in a timely manner, Increase education for the Community including awareness of our History, Home tours, Establish standards, Establish a fast track for binding review, Expand Historical District
