A Special Study Session of the Farmington City Council was held on March 17, 2014, in Conference Room A, Farmington City Hall, Farmington, MI. Notice of the meeting was posted in compliance with Public Act 267-1976.

3. PUBLIC COMMENT

No Public Comment was heard.

4. REVIEW OF PROPOSED ORDINANCE CHANGES

City Administration advised that as a result of previous discussions with Council, proposed changes have been made to the Outdoor Display, Sales, and Storage Ordinance, related to storage of propane tanks. The major changes include: the propane tank cannot exceed 20 pounds and must be stored in a locked storage

container of certain size, complies with fire and safety codes, and 3 feet of clearance for pedestrian traffic is provided.

Christiansen discussed a number of locations where propane is currently stored and sold throughout Farmington. He discussed locations where the sale of propane might be appropriate including: gas stations, convenience and hardware stores. He questioned whether propane sales would be appropriate in shopping centers or the Central Business District (CBD).

Discussion followed regarding propane sales at a local pharmacy in the CBD.

Christiansen advised the Fire Marshall has inspected all locations where propane is currently stored.

Galvin suggested changing the ordinance provision "tanks should not exceed 20 lbs." due to the fact they weigh more than 20 lbs. when they are filled.

Christiansen noted propane filling stations are approved as part of their site plans.

Council concurred to make the following changes to the ordinance: outdoor propane storage tanks are permitted at gas stations, hardware and convenience stores outside of the CBD; and change "not to exceed 20 lbs." to a 20 lb. size tank.

5. REVIEW OF FLANDERS SITE DEVELOPMENT PROPOSAL

1. Review of Flanders Site Development Proposal

Christiansen indicated three bids were received for the development of the Flanders property. He stated the Windmill Group was the high bidder for the property. He discussed process for interviewing the bidders and a request to the developers for further refinements to their proposals. He stated Windmill was the only developer that came back with refined plans. He indicated they presented two different site development proposals for the property.

Christiansen reviewed the two site plans, both of which include 34 lots with a 1.64 acre park area. The major differences are two access points with a horseshoe street versus one access point and a loop street with different locations for the park.

Responding to a question from Galvin, Christiansen confirmed the schools would only be accepting a bid and it is the city that will approve the site plan.

Discussion followed regarding the time frame for land use approval and Planned Unit Development (PUD) process.

Scott stressed the importance for the city to have a clear idea of what they want in the development.

Galvin suggested inviting the developer to a future meeting to give Council a preview of their development plans.

6. REVIEW OF STREET VACATION ITEM ON REGULAR AGENDA

1. Review of Street Vacation Item on Regular Agenda

City Administration advised that as part of the effort by the Farmington Public Schools to obtain a clear title to the Maxfield Training Center (MTC) it was discovered the property has two city streets that need to be vacated. The first order of business will be for Council to schedule a public hearing for April 21st meeting to vacate the streets.

Attorney Schultz advised the vacation of the streets requires a circuit court action due to the fact they are located within 25 meters of a water course (river). He discussed the burdensome process that this action entails.

Christiansen provided a brief history of the MTC site and why the platted streets remained. He stated the original platted subdivision with said streets remained because it was never recognized when other development occurred. He stated to obtain a free and clear title to the MTC property the formal vacation of the streets must occur. He reviewed the original plats with Council.

Scott asked about the costs related to the street vacation and questioned whether the city is subsidizing the schools in their pursuit of a clear title to the property.

Pastue pointed out the city will be the beneficiary of the potential development of that property. He stated early on the city had committed to handling the street vacation.

Discussion followed regarding keeping an accounting of the costs to the city relative to the selling of the school properties.

7. REVIEW OF CONSTRUCTION ESTIMATE NO. 8 AND CHANGE ORDER NO. 5 FOR THE 2013 STREETSCAPE & UTILITIES IMPROVEMENT

Pastue advised the city is requesting Council approval of Construction Estimate No. 8 which includes work already completed on the Grove Street and Warner/Oakland Street project along with a payment for part of the retainage.

Responding to a question from Schneemann, Pastue stated the amount of retainage remaining after payment of Construction Estimate No. 8 will be \$25,000.

Schneemann commented that seems to be a very low retainage amount.

Pastue responded the city would normally keep 5-10% retainage which would be about \$5,000.

Discussion followed regarding the \$50,000 worth of "punch list" items remaining on the project and the decision to reduce retainage from \$75,000 to \$25,000.

Discussion continued regarding work remaining on the project.

Scott commented that until the "punch list" is completed the full retainage should not be released. He pointed out a portion of the paving on Warner Street was not done properly and will have to be redone.

6. PRESENTATION/PUBLIC HEARINGS

1. 2013 DDA Mary Martin Service Award Recipient - Chris Barr

Mayor Galvin recognized Chris Barr as recipient of the 2013 DDA Mary Martin Service Award and congratulated him for his service to the community. He reviewed the list of candidates who were also nominated for the award.

Cowley provided background on the Mary Martin Service Award. He indicated this is the ninth year for the award. He noted Chris Barr and his daughter are mainstays at the Farmers Market. He also congratulated Chris on his award.

Mr. Barr expressed appreciation for the award and spoke about his volunteer activities with the DDA.

2. Commission on Aging Presentation - Jane Frost

Jane Frost, representing the Commission on Aging, was present to provide an update on Commission goals and activities.

McShane questioned how the Commission is reaching out and communicating with different ethnic groups in the community.

Frost responded a survey going out to residents 50 and over will provide a reading on the different ethnic groups in the area. She noted the Commission was invited by the Farmington Community Library to participate in the development of a strategic plan to address community diversity.

McShane questioned how the Commission is reaching out to seniors living in their homes.

Marsha Koet, Program Supervisor of the Senior Division, discussed various resources to reach seniors in their homes including: neighbors, Public Safety, discharge planners at hospitals ways, etc. She stated there is not one good answer for reaching them.

Discussion followed regarding transportation provided to seniors including the use of the SMART connector bus and dial-a-ride.

Galvin thanked the Commission members for their service to the City.

3. Farmington Area Arts Commission Presentation Nancy Coumoundouros, Jennifer Berkemeier and Cindy Carleton

Cindy Carleton, representing the Arts Commission, was present to provide an update on Commission goals and activities.

McShane requested the Commission's assistance in establishing public art in areas throughout the City.

Carleton responded the Commission would love to get involved in that kind of initiative.

Galvin asked about the recent film festival held in the community.

Carleton responded the film festival was the idea of Kickstart Farmington. She stated the Commission helped publicize the event and held a preview party. She noted two of the films were shown to sold out audiences. She stated not only was the event a huge success, but it also brought recognition and support to several non-profit agencies.

8. NEW BUSINESS

1. Consideration to Approve Proposal Regarding Grand River Traffic Analysis

City Administration noted at the last study session Council discussed a traffic analysis proposal from Orchard Hiltz & McCliment that would provide data necessary to determine whether Grand River can be modified to incorporate more parking, bike lanes, etc. No changes to the proposal have been made since the study session.

Cowley asked if there would be a need for another traffic analysis if a parking structure was built in the downtown.

Pastue responded that as redevelopment continues more analyses may be necessary.

McShane pointed out the subject of bike paths is not included in the proposed analysis.

Pastue responded the first part of the analysis is to determine if the number of lanes can be reduced on Grand River. He stated based on the result of that analysis, the next step will be to evaluate how to use the surplus right-of-way.

McShane stressed the importance of walking paths and bike lanes in our community, especially in attracting young families.

Responding to a question from Schneemann, Pastue stated the City does not yet have a commitment from the Corridor Improvement Authority (CIA) for a \$10k contribution.

Christiansen advised the CIA has set aside funds for the analysis.

Scott stated as a member of the CIA and joint taskforce, one of their goals is to ensure there is not overlap in analyses of Grand River. He also stressed the importance of bike lanes and making Farmington a more pedestrian friendly community. Responding to a question from Galvin, Pastue stated it will likely take several months before the analysis is completed and reported back to Council. He noted the finished report will be submitted to MDOT.

Motion to approve a proposal submitted by Orchard Hiltz & McCliment (OHM) to conduct a traffic analysis along Grand River from Shiawassee Road east to Orchard Lake Road.

9. DEPARTMENT HEAD COMMENTS

Eudy cautioned drivers to be aware of city crews patching roads.

Halberstadt announced the Mansion will re-open on Sunday, April 6th and invited the public to view the new exhibits and quilts that will be on display.

10.COUNCIL COMMENT

Scott noted that with all the snow and plowing, the roads kept getting smaller and smaller. He stated on a couple of occasions he could barely get his car through, let

alone an emergency vehicle. He suggested the city take a look at how to control on-street parking.

Pastue discussed the process for declaring a snow emergency. He commented this year there has been so much snow that it cannot be pushed back far enough.

Scott congratulated the Farmington High School hockey team for winning the state championship. He invited the public to attend a celebration at the Sundquist Pavilion on Wednesday, March 19th at 6:30pm.

McShane asked about scheduling a date for a joint training session for Council, Planning Commission, and Zoning Board of Appeals members.

Pastue responded possible dates would be April 14th or 28th.

Cowley noted City Council was invited by the Farmington School Board to provide input in the recruitment of a new superintendent.

Cowley stated his perspective has not changed since the last school bond proposal was turned down by voters. He discussed the importance of attracting young families and developers to the community. He does not support raising taxes since he believes they are already too high. He suggested the schools "tread water" until an outstanding millage expires in 2-3 years. At that time it can be put back on the ballot for renewal.

Cowley advised what he is looking for in the next superintendent is experience with multi-year budgeting. It is crucial that the school system works with the city to get properties back on the tax roll. He stated the next superintendent needs to pay attention to fiscal management; transparency is important; need to manage legacy costs; and should have a good track record of turnaround. He does not believe anyone in the existing regime is qualified for the position. He stressed the importance of this decision and expressed support for whatever decision is made.

Galvin spoke about action Farmington Public Schools has taken on vacant school properties. He pointed out the school board will review proposals for the development of the Flanders property at their next meeting. He noted that included in the bid for proposals that went out was a list of incentives to contractors from the city. He looked forward to the schools taking the first step on that site.

MEETING MINUTES CITY COUNCIL JOINT STUDY SESSION MEETING CITY OF FARMINGTON HILLS AND CITY OF FARMINGTON MARCH 24, 2014 – 6:00PM CITY HALL – COMMUNITY ROOM

The City Council study session meeting was called to order by Mayor Brickner at 6:00p.m.

GEORGETOWN UNIVERSITY ENERGY PRIZE:

Assistant to the City Manager, Nate Geinzer, introduced Chair Mark VanEtten and Vice Chair Leon Zolkower to say a few words regarding this program.

Mr. VanEtten stated that members of the Commissioner for Energy and Environmental Sustainability are present this evening to discuss the Georgetown University Energy Prize, which is a national program that they would like the City to take part in to reduce energy per capita. He stated that they would be working with the utility companies and schools to generate and implement plans for scalable reductions in energy that would be monitored by the utility companies. He feels this program will provide the city with excellent visibility as it is a national program.

Mr. Geinzer noted that the United States wastes over half of the amount of energy generated and to address this issue Georgetown University came up with this energy prize competition. He explained how the competition works; resources required and potential funding and sponsorships for the program. Mr. Geinzer commented that if Council wishes to proceed with taking part in the competition, he feels Earth Day would be a good day to make that announcement.

It was noted that this is a national competition by which local governments would work with area schools and residents to reduce energy consumption over a two-year period; and work with the utility companies to track their usage. The goals of the competition are to encourage innovative replicable strategies to reduce residential and municipal building energy consumption, educate the public and reward communities for their efforts. Mr. Geinzer stated that there is a \$5,000,000 dollar prize back to the community who wins this competition; and he strongly believes that the Farmington/Farmington Hills communities can be a strong competitor for that prize.

Councilmember Lerner inquired what type of budget would be required for this program. Mr. Geinzer responded that the program outline would dictate the needs and they are attempting to get sponsorship; but he would anticipate ³/₄ of a full-time staff equivalent and promotional funding.

Mayor Galvin inquired about tracking the progress. Mr. Geinzer explained that communities would be able to track their own progress against other communities participating in the program and use that for motivation.

In answer to inquiries by Councilmembers, Mr. Geinzer pointed out that this only involves residential and municipal buildings and so new or revitalized office complexes would not impact the program. He also noted that as of now there is one grand prize award, but they are discussing the possibility of additional prizes. He noted that the communities would be recognized nationally for their participation and particularly the top 10 communities would receive additional recognition. He stated that the program also not only educates the community on energy efficiency but gets the residents involved in a program that could potentially bring money back to their community for other programs, etc.

Councilmember Steckloff felt the information provided was very broad and questioned if there was a draft of the proposed program that could be sent to Council. Mr. Geinzer stated that there was not and that he needed the commitment from both Councils that there is enough interest to move forward. He then could create a team and have the Memorandum of Understanding prepared for both Councils to review.

Some concern was expressed about the potential funding that would be required for the program, but it was the general consensus of both the Farmington and Farmington Hills City Councils to move forward with the first step and submit a letter of intent and application to participate.

DETROIT WATER AND SEWER DEPARTMENT (DWSD) WATER AUTHORITY NOTION **UPDATE:**

Water Resources Commissioner Nash updated the City Councils on the future of the Detroit Water and Sewer Department. He stated that the WRC has requested audit reports and other information that they are still waiting to receive in order to make a determination if they should remain with DWSD. He noted that he will be proposing to the Board of Commissioners in April funding to conduct a study on what it would take to do their own water and sewer system. Although there are many questions involved with that, including whether the DEQ would look favorably on that or not, he feels it is worth studying.

Mr. Nash added that the rates are set by the City of Detroit yet they have more than a 55% delinquency rate and others just not paying the bills; and he does not want paying customers to be saddled with those expenses.

Discussion was held on the infrastructure and who owns that as well as what it might take for the County to have their own system.

Mayor Galvin inquired about the internal controls. Mr. Nash commented that the water quality is some of the best in the country, but the issue is with the infrastructure. He stated that the Board is dominated by the City of Detroit, but he still has staff on the Board and they do have some say. He added that his staff has faith in Sue McCormick who is involved in the management. He noted that the issues have been with the Attorneys who are handling the bankruptcy.

City Manager Brock inquired who makes the final decision on accepting or not accepting the offer from DWSD. Mr. Nash responded the Board of Commissioners would have to approve any offer.

City Manager Brock provided an update on Grand River road conditions. He noted that the State prioritized an extra \$115,000,000 towards state roads, and he completed the forms required to try and obtain some of that funding for Grand River.

PRESENTATION ON THE MIDDLEBELT TUNNEL PROJECT:

Sue Coffey, Water Resource Commission Manager, commented that this project was previously discussed with City Council. She noted that the communities' attorneys were not comfortable with the proposed contracts and they have worked through those issues. She presented City Council with the proposed project area, stating that there are 15 communities in the sanitary sewer system and discussed what portion the County owns.

Ms. Coffey noted that it was discovered that system upgrades were needed to meet requirements as sanitary sewer overflow was occurring. She stated that there are capacity issues with the current system. These deficiencies were noted in the 1980's, and they were dealt with through various projects. She stated that they now have a court ordered requirement to upgrade the system and the Middlebelt Tunnel Project is the first of several proposed projects, which would involve 4 of the communities on the system.

Councilmember Steckloff inquired why the City of Farmington Hills would be required to pay 53% of the project costs.

Ms. Coffey explained the cost allocation method used.

In answer to Councilmember Lerner, Consultant Tim Miner explained how the peak flow from Farmington Hills was measured.

Mr. Lerner commented that he could not visually grasp the percentage being charged to Farmington Hills based on the map provided. Ms. Coffey further explained that the flow was directly metered and that is the data that was used.

Councilmember Massey commented on the development to the north of Farmington Hills and also questioned Farmington Hills being responsible for 53% of the project costs based on the map and information provided. He stated that he had asked to see the figures the first time this issue was discussed and that he needs to see the data to support paying 53% of the costs.

Mr. Brock confirmed that this was rater payer funded. He added that the other communities paying for the project also questioned the costs and WRC analyzed the numbers again and came up with very similar figures.

Ms. Coffey commented that the annual cost for the average customer would be approximately \$65.75 and the minimum user cost would be approximately \$26.50

Tom Maxwell, WRC, provided construction details on the proposed tunnel project, noting that it would be 9 foot in diameter and the storage volume would be 3.6 million gallons. He showed a map of the project area and graphic illustration of how the tunnel would operate and handle the sanitary sewer overflow. Mr. Maxwell discussed traffic impact during construction and stated that they would try to maintain two-way traffic during most of the construction.

Ms. Coffey stated that the proposed contract is on the City Council regular meeting agenda for consideration.

It was noted that this construction would be taking place at the same time as the Northwestern construction and the proposed timeline is June 2014 through November 2016.

City Manager Brock stated that the contract could be approved at the regular meeting with contingencies if that was the desire of Council, but staff would like to provide Council with any information they need without delaying the process.

Ms. Coffey reiterated that the calculations were based on metered data and agreed that they need to show that.

No public comment was heard.

4. PRESENTATION

A. 2014 Founders 50Th Anniversary Festival

Janet Bloom, Director of Programs & Events, GFACC, was present to discuss the 2014 Founders Festival.

4.D

Discussion followed regarding the location of the fireworks; how the festival can benefit downtown businesses; shuttle service; sponsorships and financial goals of the festival.

5. DISCUSSION

A. Proposed Kimco Site Plan

Present: Scott Tucker, Vice-President of Leasing for KIMCO Realty, Pat McCune, KIMCO Construction Manager, Joel Volpe, Herschman Architects, and Chuck Chzran, local Kimco Property Manager.

Christiansen briefly discussed current occupancy of the KIMCO Center and proposed site plan.

Pastue invited representatives from KIMCO and Herschman Architects to discuss the proposed site plan.

Mr. Tucker discussed a proposal from Fresh Thyme Farmers Market, to occupy space in the Downtown Farmington Center. He spoke about the logistics of the project, including the need for a complete tear down, parking and delivery challenges, and visibility and signage. He stated they will seek a Planned Unit Development (PUD).

Mr. Volpe commented on the challenges of fitting Fresh Thyme Market in the proposed space. He reviewed the floor plan, elevation and proposed baler storage in the rear of the building.

Christiansen indicated Fresh Thyme is a mid-west grocery backed by Meijers. He discussed the challenges of dumpster support for the Center tenants and some of the challenges KIMCO faces in redeveloping the center.

Responding to a question from Schneemann, Mr. Volpe stated the plans are to demolish the entire section of the building where the grocery would be located.

Responding to a further question from Schneemann, Mr. Volpe stated construction staging would take place in the rear parking lot.

Responding to additional questions from Schneemann, Mr. Volpe confirmed the recessed loading dock will have a partial retaining wall; and the compactor will have a partial screen wall and would be located on city property.

Christiansen advised that in order to repurpose the center there needs to be an engagement by the city. He stated this is why KIMCO has suggested moving forward with a PUD process. This process would spell out every activity associated with the redevelopment of the property.

Responding to a question from Schneemann, Christiansen stated the encroachment into Orchard Street in the rear of the building will not impact the travel portion of that street.

Pastue advised he has held off redoing Orchard Street knowing this area would eventually be redeveloped. He stated future needs of the property will probably dictate reconstruction of the road.

At the request of Schneemann, Mr. Volpe discussed the architectural design intent of the project. He stated the attempt was to marry the typical facade of the grocer and the requirements of the city.

Schneemann referred to the progressive redesign of The Groves Center and his desire to see something more innovative for the proposed KIMCO tenant. He would like to see something that compliments the existing architecture, but would take it up a notch.

Scott, in referring to the proposed design, expressed disappointment in the rehash of the 60's retail model. He noted KIMCO has had the opportunity to review the City's vision plan and what the city would like for that site. He stated instead they came in with a scrape and rebuild with some encroachment. He would like to see more responsiveness to the vision plan before he can support the project.

Scott stated he knows KIMCO can do better on the truck well so that it is totally within the building. He would like to see a mixed-use, multi-level development on that site. He stated the city has been dealing with the issue of having a strip mall in the downtown. He expressed concern regarding the building height in relation to the rest of the center. He understands it is KIMCO's property, but would like to see some give and take with the city in the design.

McShane commented she understands the proposed plans are preliminary. She expressed excitement to see this project move forward. She believes it is a wonderful opportunity for both KIMCO and Farmington. She noted there are a number of opportunities where compromise can be reached. Ideally, she would like to see Fitness 19 moved and have the side of Fresh Thyme Market on Farmington Road where they would have good visibility. She would also like to see a pass-thru where Tuesday Morning meets Fresh Thyme. She noted the south parking lot could be redone with the elimination of the park.

McShane stated the proposed building does not bother her and sees it as a tie-in to the eastern section of the center. She would like the city to work with KIMCO to make this project happen.

Responding to a question from Cowley, Mr. Tucker stated the estimated value of the project investment is approximately \$3 1/2 million.

Cowley expressed excitement about a 2-story structure and connecting one parking lot to the other. He asked how many additional parking spaces would be needed to make the market successful.

Mr. Tucker responded probably a lot more than is currently there. He stated

there would be more business opportunity with additional parking.

Responding to a question from Schneemann, Mr. Volpe stated Fresh Thyme typically stores carts inside their stores.

Cowley expressed support for the proposed tenant and believes it would be a home run for the downtown. He advised linking the two parking lots would be a crucial element to the success of the center.

Christiansen stated that based on the square footage of the proposed building approximately 150 parking spaces would be needed.

Galvin thanked the KIMCO representatives and Mr. Volpe for their presentation. He believes a market is the right fit for the proposed location. He believes all parties involved should come out winners. He stated Scott's comments resonated with him. He does not know that refilling the same footprint is the optimal solution. He would like to see different plan designs. He noted the Downtown Master Plan calls for a different design on Orchard Street.

Galvin asked how the property can be integrated with the neighborhood to the south rather than functioning as a barrier. He believes there is a solution and options should be explored. He noted the city owns property to the south. He stated the property needs to be consumer friendly. He cautioned that a Council decision will impact the city 40-50 years out.

Mr. Tucker spoke about the challenges of the center and that it would not be economically feasible for KIMCO to tear it down and rebuild.

Pastue asked about the timetable for the project.

Mr. Tucker stated they would like to have it done by this fall, but realistically not until spring. He stated if the project was delayed until the middle of next year the deal would probably fall through.

Responding to a question from Schneemann, Christiansen confirmed the plans would be required to be presented to the Downtown Development Design Committee.

Scott reiterated his belief that KIMCO can do better on this project.

6. BUSINESS ITEM

A. Consideration to Approve Construction Estimate No. 8 and Change Order No. 5 for the 2013 Streetscape & Utilities Improvements

City Administration requested payment of \$298,431.49 to Warren Contractors for work completed on the Grove Street and Warner/Oakland Street projects and change order #5 increasing the contract amount by \$54.20. It was noted this item was pulled from the March 17th regular agenda as a result of discussion at the study session prior to the meeting. More detail has been provided in the current staff report regarding work remaining on the project.

Schneemann confirmed with City Administration that after this payment, the remaining retainage would be \$30,000 and the amount of the contract yet to be earned is \$21,500, totaling \$51,500.

McShane expressed concern regarding the length of the punch list and the possibility that the contractor may walk and leave some of the project undone. The contractor may decide the work remaining is not worth what the city owes them. She recommended establishing a timeline to complete the work.

Pastue advised the work should be done within a month. He stated many of the punch list items can be completed quickly. He believes the contractor is interested in the finishing the project and maintaining their reputation.

Scott pointed out that the manhole near Los Tres Amigos needs to be adjusted and noted it is not on the punch list. He asked if Orchard Hiltz has identified the value of the punch list.

Pastue responded no value has been placed on the list.

Scott would also like the establishment of a timeline for the work to be completed. He stated retainage should be released based on a time commitment.

Pastue recommended placing a May 15th deadline in the motion.

Responding to a question from Cowley, Pastue stated the Los Tres Amigos dumpster will not be enclosed as part of the project.

Schneemann and Scott recommended withholding \$50k in retainage.

Scott asked how the city will ensure the timeline is met.

Pastue will require the contractor to sign an affidavit that work will be completed by May 15th.

Motion to approve construction estimate #8 with Warren Contractors in the amount of \$278,431.49, maintaining a retainage of \$50,000, and approve change order #5 increasing the contract amount by \$54.20; with the stipulation that all punch list items and remaining work be completed by May 15, 2014.

9. DISCUSSION

1. Parking Authority

Pastue stated one of the goals identified in the 2014-2015 Work Plan was to establish a parking authority. He advised the City Attorney was asked to provide information to facilitate this process. He asked Attorney Saarela to review her findings.

Attorney Saarela advised the State of Michigan does not have a statute that would authorize the city to create a "parking authority." She discussed four options to finance and build a parking structure including: 1) the city could own the structure and finance it through revenue bonds to be paid in user fees; 2) the city could own the structure and finance it through special assessments; 3) the city could create a building authority to own the structure and finance it using bonds; and 4) the Downtown Development Authority (DDA) could construct and own the facility and finance it through any option available to a DDA.

Pastue recommended establishment of a "parking authority" by ordinance since there are no state statutes that apply. He cited a number of questions that need to be answered regarding this process.

Galvin reviewed his findings from 7-8 communities of similar size to Farmington that have parking structures. He stated only one of the communities had a "parking authority" listed under its boards and commissions. He noted at least one of the communities privatized its structure.

Cowley expressed his belief that a parking structure cannot be done without private investment and in turn there must be a tax advantage and return on investment.

Pastue discussed the different revenue streams that would be involved in financing a parking structure. He stated an authority would have the responsibility to coordinate financing.

Cowley stated he is looking for the "parking authority" to do the entire strategy.

Responding to a question from McShane, Pastue stated the authority would cover downtown parking only.

McShane discussed the wide range of responsibilities given to a parking authority. She liked the idea of a board with four members at-large and one city councilmember. She noted the authority is no small job.

Scott stated he sees the possibility for a parking structure on the east side of the city and suggested an authority should cover the entire community.

Schneemann expressed concern there is no state statute for a parking authority and that there are very few communities that have one. He pointed out that an authority seems tied to a structure, however, there are other challenges that need to be addressed regarding parking. He stated an authority could pursue other options to a parking structure. He suggested this group could be labeled something other than an authority.

Discussion followed regarding how the city will define the scope of an authority and finding a model that could be adapted to Farmington.

Galvin spoke about the need for the authority to be aware of all forms of transportation, including pedestrians.

Schneemann suggested the authority should have a liaison to the DDA Design Committee.

McShane expressed the need for the authority to have sufficient time to study the issue extensively before a recommendation is made. She pointed out a nearby city where two parking structures were built that are not being used.

Pastue advised he will do further research on parking structures including talking with other cities in an effort to create a model.

Responding to question from Cowley, Pastue suggested a goal of 90-120 days to draft an ordinance and provide to Council for a first reading.

Cowley suggested an authority that could start working on signage; meters on Grand River; revenue streams; coordination with existing parking lots and options on property. He state there is a lot that can be done without getting to the parking structure conversation.

Cowley would like to bring back valet parking in the downtown next winter and he would contribute financially to that effort.

Schneemann emphasized that alot can be done by a parking authority without necessarily going to a parking structure.

McShane suggested using the Traffic and Safety Board to address some of the parking issues.

10.CITY MANAGER UPDATE

Pastue provided an update on several ongoing issues/projects in the city as follows:

Grand River made the first cut for the \$115 million legislative appropriation for road repair. He met with residents who live on Grand River that are very frustrated with the lack of progress in repairing the road. He stated the city will clean up some of the debris from the road that ended up in their yards.

Work will begin on the Caddell Drain with an end of June deadline.

Continue to work with the State Historic Preservation Office (SHPO) regarding the Farmington Road project. SHPO wants to see a complete design before they will provide an answer. Knowles advised a representative from SHPO has finally agreed to come to Farmington a couple of times for the planning review of the project.

The school board has approved a proposal for the development of the Flanders property and now the PUD process will move forward.

SMART is asking for an increase from .6 mil to 1 mil. There was no indication from them early on that this increase was being contemplated.

A community meeting was held recently to discuss with residents and business owners redevelopment in Farmington and the 2014-15 Council work plan. Director Christiansen also participated in this meeting.

A joint special meeting with the Planning Commission and Board of Zoning Appeals will be scheduled for Monday, April 28th.

A Council retreat will be scheduled to discuss redevelopment plans.

Christiansen discussed the upcoming Planning Commission meeting where four site plans will be presented. He commented on inquiries received for the Kmart Center.

Pastue and Christiansen will meet with representatives from the Historical Commission regarding historical structures that are vulnerable due redevelopment.

Discussion followed regarding the Historical Commission and the pursuit of a certified historic district.

11.COUNCIL COMMENT

McShane pointed out the City Council has never had the desire to preserve historic homes. She stated if the city had an Historic District Ordinance homes that are contributing would be saved. She noted if the city started knocking down homes that people consider to be an integral part of Farmington's charm they will come out in huge numbers.

4.D

Schneemann recognized the city needs something in place that helps preserve properties in the Historic District. He stated any action needs buy-in from residents in the district.

Responding to a question from Cowley, Pastue confirmed Representative Barnett is providing assistance on funding for repairs on Grand River. Pastue stated the brewery is still working out the details on its lease.

Galvin requested City Administration draft a resolution regarding repairs needed on Grand River. The resolution can be voted on at the next meeting. He would be willing to take it to Lansing.

MONTHLY REPORT MARCH 2014

COUNTERFEIT MONEY

On March 1st, at approximately 6:29 p.m., an employee of the Original \$3 Car Wash came into this police department to report a counterfeit twenty dollar bill. The complainant advised that he had received the twenty dollars as a part of his share of the tips that are collected throughout the day. The complainant attempted to use the money at McDonalds but was advised that the money was not real. The reporting officer verified the money as counterfeit and the report was forwarded to the Detective Bureau for further investigation.

ASSIST OTHER DEPARTMENT

An officer on patrol overheard Farmington Hills police dispatch one of their units to a Larceny in a Building that occurred at the Dunkin Donuts at Eight Mile and Grand River. The officer assisted Farmington Hills police who was out with the subject in front of Botsford Hospital.

DRIVING WHILE LICENSE SUSPENDED

On March 3rd, at 3:02 a.m., an officer stopped a vehicle near Grand River and Drake for improper lane use. The driver of the vehicle produced a Michigan ID card as identification. A check of his driving record revealed that he had a suspended driver's license. The driver also had in his possession Marijuana but he is a medical marijuana card holder. The driver was arrested and transported to the station where he was house.

OPERATING WHILE INTOXICATED

On March 3rd, at approximately 7:21 p.m., an officer was dispatched to the Eight Mile and Farmington Road area for a report of a motor vehicle accident. Upon arrival the officer made contact with the at-fault driver who was still seated behind the wheel of her vehicle. The officer noted that the driver exhibited signs of intoxication and learned that she had been drinking wine prior to driving. The woman failed several sobriety exams and was arrested for Operating While Intoxicated. The woman was transported to the Farmington jail where she submitted to a breath test. The woman's breath alcohol content was a .25 and she was held at the Farmington jail.

POSSESSION OF PRESCRIPTION DRUGS/POSSESSION OF MARIJUANA

On March 4th, at 1:49 a.m., an officer stopped a vehicle near eastbound M5 near

Farmington Road for swerving outside of its lane and an equipment violation. Upon speaking to the driver, the officer could smell Marijuana. When asked, the driver admitted to having Marijuana in the vehicle and produced some. The driver was arrested for Possession of Marijuana and seated in the officer's patrol vehicle. The officer searched the vehicle and located forty-nine (49) morphine pills that the driver did not have a prescription for. On March 6th, at approximately 8:51 p.m., a resident came into the police station to report that he had been struck by a vehicle earlier in the day. 



The Farmington Public Safety Department is proud to provide a yearly report to the council, city manager and residents of Farmington. The following report will provide you with a review of crime data, major cases, new community policing programs, new technology and an overview of the public safety department.

We are pleased to announce for the sixth straight year that "Part A" crimes (most serious) decreased in 2013 by 17.8% (323 vs. 393). As part of that, assaults were down 19.6% (57 vs. 46 in 2013), larcenies were down 28.4% (116 vs. 83 in 2013), and malicious destruction of property was down 27% (36 vs. 26 in 2013). Unfortunately, there was a 25% increase in burglaries (21 vs. 28 in 2013) and the there was one homicide in 2013, the first since 2007. The suspect is currently awaiting trial in this case.

The public safety department responded to over 700 calls for service involving a sick or injured person and an additional 137 calls for service involving a fire related incident such as down wires, odor investigations and structure fires. There were no fire related injuries or deaths. The department handled a fatal motor vehicle accident in 2013, the first since 2010.

The department continued to seek out opportunities to improve the services provided to the community. A drug "take back" program was started to provide a safe way to properly dispose of unwanted prescription medication, Crimemapping.com was started to allow residents to see what crime is occurring in their neighborhood and we held our first open house in over twenty years. These are just a few of the highlights of this year's annual report.


It should be noted that crime data figures contained in this report may contain slight number variations. This is due to the ongoing reclassifications of incidents determined to be civil, items reported stolen that were misplaced, lost property determined to be stolen, etc.

On behalf of the proud members of the Farmington Public Safety Department, we again thank the city officials for your support. I am pleased to present the 2013 Annual Report.





DEPARTMENT ACCOMPLISHMENTS

DEPARTMENT ACCOMPLISHMENTS (2013)

- There were no fire related deaths.
- No public safety personnel were seriously injured or killed in police or fire activities.
- Serious "Part A" crime decreased 17.8% in 2013. This decrease follows a 11.3% drop in 2012.
- One hundred fifty-six (156) fewer "Part A" crimes occurred in 2013, compared to 2009. This is a thirty-two percent (-32%) reduction in five (5) years.
- Total number of residential burglaries decreased to ten (10) in 2013. This is the lowest in the last ten (10) years.
- The public safety department conducted over twelve hundred (1,200) Apartment Watch patrols conducted by vehicle, bicycle and foot patrols.
- Twenty-one (21) members of the public safety department attended a two (2) day Response to Active Shooter training conducted by the Oakland County Tactical Training Consortium (Oak-Tac).

COMMUNITY POLICING

COMMUNITY POLICING

The Farmington Public Safety Department embraces community partnerships that promote effective police and fire services. Seventy (70) special services and programs focus on youth, neighborhoods, roadways and the businesses in our community. New or revised programs in 2013 are noted in bold print.

ALCOHOL TESTING

In cooperation with the probation department at the 47th District Court, the public safety department is testing probationers for the use of alcohol each morning.

ANIMAL TRAPPING PROGRAM

The department loans animal traps to residents (returnable deposit fee).

APARTMENT WATCH PROGRAM

The public safety department received a COPS Hiring Recovery Program (CHRP) grant to replace a vacant public safety officer position. The department has increased police patrols, bike patrols and foot patrols in the city's thirty-four multi-housing communities. Monthly crime prevention presentations are part of the program.

AUTO IMPOUND

Public safety officers electronically complete impound paperwork when impounding vehicles, which automatically sends the necessary information to the tow companies.

BICYCLE SAFETY EVENTS

The Farmington Public Safety Department, along with LOC Federal Credit Union and AAA, sponsors bicycle safety events. The department also sells bicycle licenses to help identify lost or stolen bicycles.

BLOCK PARTIES

Department personnel visit neighborhood block parties with police cars and fire trucks, and distribute crime and fire prevention materials.

BUSINESS WATCH

Special meetings, programs and crime alerts are coordinated with the members of our business community.

CHILD CAR SEAT SAFETY INSPECTION

Citizens can have their child's car seat inspected for safety, proper installation and compliance with State law by the department's fire marshal who is a graduate of the National Child Safety Certification program. The department also has a limited number of free car seats to distribute.

CITIZEN AWARD RECOGNITION PROGRAM

The department recognizes members of the community who assist the public safety department.

COMMUNITY POLICING

CIVIC ORGANIZATIONS

Members of the department participate in thirty-eight (38) community and professional organizations.

CLICK IT OR TICKET

In addition to regular seat belt enforcement, the department participates in annual Memorial Day selective enforcement initiatives. Such initiatives save lives, reduce injuries, and help keep Michigan ninety-four percent (94%) compliant.

COMMUNITY COALITION WORKSHOPS

Members of the department participate in substance abuse and relationship violence workshops and programs.

COMMISSION ON CHILDREN, YOUTH & FAMILY

The department participates in the community commission and their events that promote the children, youth and families of our community.

COMPLIANCE CHECKS

The department conducts several annual alcohol and tobacco operations to discourage sales to minors.

CRIME ALERTS

The department expanded the capabilities of the department's crime alert notification system by utilizing Nixle software. Residents can now choose to receive text messages or Twitter communications. The public safety department can now send photographs and area messages with the alerts.

CRIMEMAPPING.COM

Citizens can log onto <u>www.crimemapping.com</u> to view up to date crimes that have occurred in their neighborhood.

CRIME PREVENTION NOTICE PROGRAM

Public safety officers issue crime prevention notices and warnings to residents. Examples include warnings issued to residents who leave valuables unattended, doors unlocked or garage doors open.

CRIME WATCH WEBSITE

Farmingtonpublicsafety.com is the web address. The site features crime statistics, Neighborhood Watch information, annual reports and other items of interest.

CROP WALK

The department coordinates participation and the safety of three hundred annual walkers who raise money for the needy.

<u>CROSSING GUARD PROGRAM</u>The department hires, manages and conducts annual training for school crossing guards at designated schools.

COMMUNITY POLICING

DECOY CARS

The department strategically places unoccupied patrol vehicles on streets to deter speeding and in business areas to discourage crime.

DRUG TAKE BACK PROGRAM

Residents can take their old prescription drugs to the Public Safety Department (24 hours a day, 7 days a week) and have the drugs destroyed safely.

DTE STREET LIGHT DETAIL

In cooperation with Detroit Edison (DTE), public safety officers check all the street lights in the city each month and report any outages to DTE for repair.

E-CRASH

Public safety officers electronically complete accident reports. Motorists and insurance companies can still obtain copies of the reports electronically.

FACEBOOK

""Like" us on Facebook to get the latest Farmington Public Safety Department information and updates.

FARMINGTON YOUTH ASSISTANCE

Department members attend board meetings and make appropriate referrals as an alternative to criminal prosecution.

FIRE INSPECTION PROGRAM

The department is proactive in conducting fire inspections to reduce loss of life and property.

FIRE SAFETY/PUBLIC EDUCATION PROGRAMS

The department conducts various fire safety education programs to pre-schools and other community groups.

FIRST AID, EMERGENCY PROGRAM

The department participates in several educational programs such as the Emergency Preparedness Commission.

FOOT BEAT PATROLS

Public safety officers are assigned to foot patrols in the downtown center and at special events.

FRAUD-NET

Detectives fight fraud and bank crimes with an on-line database linking bankers and law enforcement officers. The partnership promotes crime prevention and helps solve crimes.

GUN LOCK GIVEAWAY PROGRAM

The department gives away free locks to residents to promote gun safety.

HALLOWEEN FESTIVAL, CANDY PATROL

The department participates in the safety coordination at special Halloween events. Special patrols target neighborhoods and officers give away Halloween treats.

HAZARDOUS MATERIALS TEAM

Fire Marshal Madeline represents Farmington on the North Oakland County Hazardous Materials Response Team.

HOLIDAY ALCOHOL ENFORCEMENT PROGRAM

This award winning program utilizes public education, compliance operations, special patrols and partnering with several community organizations and the business community.

HOUSE CHECK PROGRAM

Residents may notify the department when their homes may be vacant for a period of time. The information is kept in dispatch and is helpful when the need arises to contact the homeowner should a crime or emergency occur.

INTERNSHIP TRAINING

College students or individuals interested in public safety who reside or work in Farmington may apply for internship training and education.

JAIL DIVERSION PROGRAM

Public safety personnel are trained to divert mentally ill prisoners into treatment facilities as an alternative to jail.

KNOX BOX PROGRAM

The department coordinates the installation of security boxes for elderly or handicap residents. The boxes contain keys to allow public safety personnel easy emergency access.

LOST AND FOUND ANIMALS

The department logs lost animal information to help locate owners when animals are found.

MiHAN

The department partnered with the Michigan Health Alert Network to electronically receive critical emergency public health information. Public safety officers utilize the information to properly respond to public health emergencies.

MISSING CHILDREN PROGRAMS

The department participates in child identification efforts. Policies and procedures are

in place for quick activation of "Amber Alert" and "A Child Is Missing" programs. One thousand residents a minute can be notified by telephone to watch for a child.

MOUNTAIN BIKE PROGRAM

The department has three mountain bikes used by officers at special events and during specific tactical operations.

MULTICULTURAL, MULTIRACIAL COMMUNITY COUNCIL

The department is represented on the steering committee and participates in the philosophies and programs of this important group.

NARCOTICS SUPPRESSION UNIT (NSU)

Specially selected officers investigate illegal drug tips, execute search warrants and arrest drug offenders.

NEIGHBORHOOD WATCH

The department conducts monthly meetings with residents to teach crime prevention and provide crime updates. Special crime alert bulletins are delivered by community policing officers to neighborhoods experiencing crime.

OPERATION SAFE RIDE

The department partners this project with Mothers Against Drunk Driving to coordinate safe rides home for individuals consuming excess alcohol on New Year's Eve.

PARADE COORDINATION

The department participates and ensures community safety at the Little League Parade, Homecoming Parade, Memorial Day Parade and Founder's Festival Parade.

PARENT FORUMS

The department partners with Farmington Public Schools to present annual crime prevention programs at parent educational forums.

POLICE BENEVOLENT ASSOCIATION

The Farmington Public Safety Department, Farmington Hills police and fire departments and the Franklin Police Department hosts an annual golf outing, dinner and raffle, as well as live and silent auctions. The event raises funds to assist public safety personnel, their families and members of the general public during times of death, illness or personal crisis.

PRIVATE PROPERTY ACCIDENT PROGRAM

The department responds to private property vehicle crashes, preserves the peace and records the facts on a police report.

PUBLIC SAFETY TOURS AND PRESENTATIONS

The department provides tours of the public safety building, vehicles, and responds to public safety requests for speakers and presentations.

RECRUITMENT PROGRAM

The department actively recruits officer candidates at universities, colleges and academies. Applications are released throughout the year.

RESERVE FIREFIGHTER PROGRAM

The department recruits, screens and trains members of the community who supplement fire and civil defense protection.

SCHOOL LIAISON OFFICER PROGRAM

This successful program has serviced all Farmington public schools since 1990. Officer Christine Schutz is assigned to Farmington High School. She provides on site support to school administration, provides classroom instruction, serves as a connection with students, provides special presentations to parent groups, serves on various school committees, conducts crime prevention and enforcement, and investigates criminal matters occurring at the school.

SCHOOL SAFETY PROGRAM

The department is prepared to respond to all types of school and community emergencies. The Farmington School District Director of Safe Schools and department personnel meet regularly and discuss concerns and safety issues. The public safety department maintains special equipment in each patrol vehicle should a serious incident require a rapid response.

SELECTIVE ENFORCEMENT PROGRAM

Patrol officers conduct weekly selective traffic enforcement details at various locations throughout the city, several at the request of residents and Traffic and Safety Board members.

SERVICE COMPLIANCE PROGRAM

The department promotes professional traffic stops and maintains a formal complaint procedure. The department also utilizes in-car cameras to verify professional conduct and re-create a factual record of public contacts.

SMOKE ALARM GIVEAWAY PROGRAM

The department provides free, battery operated smoke detectors to residents of the community.

SOBRIETY COURT HOME VISIT PROGRAM

Commander DuLong, Sergeant Friess, PSO Schutz, PSO Morche and PSO Wash visit the homes of residents arrested for drunken driving to encourage sobriety.

SPECIAL EVENT COORDINATION

The department plans and coordinates public safety personnel for special community events. Special operational orders are written defining department procedures.

COMMUNITY POLICING

SPECIAL PATROL PROGRAMS

The department identifies areas for special tactical patrols of uniformed or plain clothes officers. The department also honors requests for special attention patrols from residents and business owners.

SPEED TRAILER PROGRAM

The department identifies areas requiring "speed awareness" and "deterrence." A strategically placed trailer informs passing motorists of their speed. The department honors reasonable suggestions for trailer placement from residents and business owners.

START

The department participates in the Safe Therapeutic Assault Response Team. Investigators are partnered with specially trained forensic nurses to collect sexual assault evidence and counsel sexual assault victims.

TEDDY BEAR GIVEAWAY PROGRAM

The department stocks donated teddy bears to give to children who are involved in traumatic events.

TRAFFIC AND SAFETY BOARD

The department acts as a liaison with the city's traffic board and traffic engineer. Public safety officers encourage citizens with unsolved traffic concerns to contact the Traffic and Safety Board.

TURN AROUND PROGRAM

Students at Farmington schools who turn their lives around in a positive manner are honored at an annual banquet. The department is a major sponsor and members serve on the planning and nominations committees.

VEHICLE LOCK OUT PROGRAM

Public safety officers respond to assist citizens locked out of their vehicles.

WASTE WATCH

The department partnered with community Waste Management workers who are trained to act as extra eyes and ears to report crime.

WEATHER EDUCATION PROGRAM

The fire marshal coordinates weather and tornado alert publications for free distribution to the public. The department also promotes public education and notification during tornados and severe weather alert month.

The Farmington Public Safety Department added five (5) new technologies in 2013, one (1) new technology in 2012, one (1) technology in 2011, six (6) technologies in 2010, six (6) in 2009, five (5) in 2008, nine (9) in 2007, seven (7) in 2006 and fifteen (15) in 2005. Fifty (55) new technologies have been introduced in the past eight (8) years to enhance public services.

PATROL DIVISION

The uniform patrol division was led by Commanders Terrance Purves, Theodore Warthman and Justin DuLong in 2013. Four sergeants; Jeffrey Brow, Richard Friess, Todd Anderson and Bob Houhanisin assist the commanders. Nine public safety officers are assigned to the patrol division: Richard Hennessy, Scott Herrmann, Aaron Malewski, Alan Baranski, Mark Keeley, Patrick Spelman, Shane Wash, William Wood and James Wren.

Five Cadets allow for city hall and the department to remain open twenty-four (24) hours a day, seven days a week for citizens and visitors to Farmington. The cadet staff also allows the department to keep its own jail which allows for Farmington officers to remain in Farmington. Other responsibilities of the five cadets include assisting records personnel, cleaning of the station, and answering business phone calls to the Public Safety Department. These cadets are Alicia Trotter, Matthew Council, Paul Hughesdon, Eric Harris, and Kevin Kohlert. They are assisted by two (2) fire reserves who are cross trained to handle cadet responsibilities when the cadets are not working. The cross trained fire reserves are Sean Skinner and John Dresden.

The patrol division prides itself in its fast response to police, fire and medical emergencies. A quick response time allows for public safety officers to mitigate emergencies quickly and efficiently while reducing further harm. The "Apartment Watch" program encourages officers to aggressively patrol apartment complexes resulting in arrests and crimes being prevented. Patrol officers also aggressively enforce traffic laws including motor carrier and "drunk driving" laws which makes for much safer roadways throughout the city.



The patrol division provides numerous community policing services. For example, our officers patrol neighborhoods and issue crime prevention notices (blue cards) indicating potential criminal opportunities, hazards or concerns observed at a residence. Station tours, visiting block parties, picking up stray pets, assisting residents who have fallen, home/vehicle lockouts, selective enforcement on neighborhood streets and any other requests for assistance from

citizens are just some of the services that the patrol division provides and residents enjoy. The patrol division understands the important connection between its officers and the community's residents and looks forward to serving them in any way possible.

SPECIAL OPERATIONS

The Officer-in-Charge of the Special Operations Unit is Commander Frank Demers. The commander supervises Detective Andrew Morche, Detective Scott Brown, and School Liaison Officer Christine Schutz. The Fire Marshal, Sergeant Reginald Madeline, is also assigned to the Special Operations Unit.

Special Operations personnel are responsible for some of the following functions: Criminal investigations, evidence technician services, crime scene photography, fire inspections, fire equipment maintenance, reserve firefighter background investigations, Neighborhood Watch, evidence and property room management, school liaison program, solicitor permits, and compliance operations for alcohol, tobacco and massage facilities.

In 2013, Special Operations personnel received specialized training in the following topics: Building Fire Safety & Plan Review, Cyber-Crime Investigations, Cell Phone Investigations, Indoor Marijuana Grow Investigations, Complex Case Investigations, Search Warrant Law & Practice, Firefighter Safety & Survival Training, Advanced Sexual Assault Investigations and Juvenile Justice Training.

FIRE SERVICE

Fire Marshal Reginald Madeline oversees the department's fire and medical operations. As a part of his regular duties, the fire marshal conducts fire inspections, schedules and performs maintenance on the department's fire apparatus and coordinates monthly fire fighting and medical training. All sworn personnel are certified firefighters and medical first responders. Four members of the department have advanced medical training and are licensed emergency medical technicians. Additional services provided by the department's fire service include; fire extinguishment, hazardous materials response, smoke alarm give away program, public education seminars on fire safety, first aid, infant/child safety seat inspections and the commercial/residential Knox Box program. Due to quick response times and quality training, the total fire loss in 2013 is estimated at \$692,500.00.

RECORDS AND COMMUNICATIONS

On October 1, 2012, Farmington Public Safety ceased being a Public Safety Answering Point (PSAP). Farmington Hills dispatch assumed the responsibility of dispatching all emergent and non-emergent calls for the Farmington Public Safety Department.

Records personnel continue to process all requests for reports (police, fire, medical and accidents), including Freedom of Information requests. They are also responsible for the processing of court dockets and subpoenas, false alarm billing, bicycle licenses, parking permits, non-criminal fingerprints, police clearance letters, warrant processing/validations and requests for station tours.

TRAINING

The public safety department continues to seek out training opportunities for both sworn and civilian personnel to increase both knowledge and practical skills. The following pages are the training courses personnel attended during 2013.

POLICE TRAINING

- Security Issues for Places of Worship: A one day class, sponsored by the Michigan State Police, focusing on security and being ready for critical incidents that may occur at places of worship.
- **PPCT Instructor Recertification:** A three day class that recertifies the department PPCT instructor in hand to hand defensive tactics.
- Use of Forces Legal Issues Updates and Litigation: A two day class, sponsored by Michigan Risk Management, that focuses on a multitude of legal issues surrounding the police and incidents involving force.
- Street Crimes Seminar: A three day class hosted by the Oakland County Sheriff's Department that concentrates on a wide range of patrol strategies and tactics for the road officer.
- **Commercial Motor Vehicle Enforcement:** A two day class that is designed to give officers the ability to take enforcement action upon commercial vehicles in regards to their length, width, height and weight.
- **Simunition Instructor Recertification:** A required two day class for the department simunition instructor to attend to retain recertification. Simunition training is performed periodically throughout the year by officers.
- **Cellphone Investigations:** A two day class hosted by the Dearborn Police Department that covers the search and seizure basics specific to mobile devices.
- **Basic Investigator School:** A four day class designed for the new detective that covers such topics as search and seizure, forensics, and intelligence gathering.
- **Glock Armorer Course:** A one day class, sponsored by our department, that certifies an officer to perform maintenance and advanced functions on our department weapons.

TRAINING

- First Responder to Death, Injury, and Sexual Violence Scenes: A three day class sponsored by the Troy Police Department that focuses on the initial response of patrol and investigating officers to incidents of death, injury, or sexual assault.
- **Dealing with the Aftermath of Trauma:** A one day class presented by a nationally renowned speaker that concentrates on dealing with the stresses of a critical incident.
- **Auto Theft Investigation:** A free, one day class that focuses on advanced stolen vehicle tactics and topics such as re-tagged passenger vehicles.
- **Human Trafficking:** A one day class hosted by the Troy Police Department that addresses the aspects of human trafficking and sex trafficking.
- **Organized Retail Crime Investigation:** A one day class hosted by the Canton Police Department that helps investigators gain a better understanding of organized retail crime and how to effectively investigate them.
- **Complex Case Investigations:** A free one day class that looks at areas where investigations sometimes fail and gives ideas of how to overcome those failures.
- **CLEMIS Cool Tools:** A free one day class that teaches officers about advanced techniques that can be used by officers for investigative purposes.
- **Hate Crimes Training:** A free one day class provided to help officers identify hate and bias crime activity.
- **Juvenile Justice Training:** A free one day class provided by the Oakland County Prosecutors Office provided a good review of best practices related to juvenile enforcement and procedure.
- Active Shooter Training: Free training provided by Oakland County Tactical Training Consortium (OakTAC) for responding to active shooter incidents.

FIRE TRAINING

- **Safety and Survival Conference:** A three day class hosted by the Farmington Hills Fire Department that concentrates on fire injuries and deaths and how they can be avoided.
- Legal Liability for the Fire Inspector: A one day class sponsored by Schoolcraft College that looks at legal liability of the fire inspector.

- Fire Cause and Origin Training: A two day course that concentrates on fire cause and origin investigations.
- **Sprinkler System Plan Review Seminar:** A one day course that gives the participant the knowledge to perform the review of sprinkler system plans and installation.
- Plan Review of Kitchen Hood Extinguishing Systems: A one day course that focuses on the basic plan review, inspection, and system testing requirements for kitchen hood suppression systems.
- Incident Safety Officer: A free two day class that teaches the participant the things that need to be monitored on a fire scene to ensure the safety of everyone.
- **Storage Wars:** A one day class that focuses on the restrictions for storage within commercial buildings.
- **Burn Training:** All department members completed live burn training at a burn building located at the Wixom Fire Department.

In addition to the above training, below is a list of training that was conducted at the City of Farmington throughout the year of 2013:

- Incident Command System
- Firefighter Survival
- Pump Operations and Hand Lines
- Firefighter Accountability
- Annual Fire Truck Drivers Training
- HAZMAT Refresher Training
- CPR and AED Training (Medical)

In the summer of 2013, the department was able to utilize Dunleavy's Pub prior to it being torn down for fire training. Department members were able to practice ventilation and search and rescue evolutions in the building.

The public safety department seeks annual supplemental funding sources through grants and partnerships to enhance services and reduce taxpayer expenses. This section of the Annual Report summarizes some of the grants utilized or received in 2013.

CAR SEAT SAFETY INSPECTIONS

The public safety department partnered with LOC Federal Credit Union and "Safe Kids" of Macomb County to provide car seat safety inspections. Approximately thirty (30) child seats were inspected for proper installation. This annual event is held the first Saturday in June at LOC Federal Credit Union (Farmington branch). The event is free to all who are interested.



DEPARTMENT OF JUSTICE BULLETPROOF VEST GRANT

The public safety department applied for and was awarded a grant to assist with the purchase of bulletproof vest for individual officers. Six (6) officers were able to purchase bulletproof vest with 50% of the cost being covered by the grant. The grant was just under \$2,000.00.

FIRE SAFETY PROGRAM

The public safety department partnered with Farmington Hills Fire Department for a fire safety program titled "Fire Safety with the Superheroes." This program was shown to a total of fourteen (14) elementary and middle schools in the Farmington Public School District. It reached approximately 5,800 students and 280 faculty members and parents. The program covered fire safety topics such as: "Stop, Drop and Roll", don't play with matches or lighters, 9-1-1, smoke alarms, "Don't Hide, Go Outside", Two Ways Out, escape plans, meeting place and "Once Out, Stay Out."

MAJOR INCIDENTS

2013 MAJOR INCIDENTS

The following incidents are a synopsis of major incidents receiving community wide attention in 2013.

FEBRUARY 13, 2013-AUTO THEFT

A City of Farmington resident reported that her vehicle was stolen from her apartment complex parking lot. Investigators networked with area police agencies to attempt to develop suspect(s) in the crime. After a lengthy investigation, three (3) suspects were identified. The suspects were interviewed and confessed to their involvement in the theft. The suspects admitted that the vehicle was taken to a "chop-shop" in Detroit. The suspects were subsequently charged with Unlawful Driving Away of an Automobile, a five (5) year felony.

FEBRUARY 24, 2013-HOMICIDE

A City of Farmington resident reported that his girlfriend was missing. Investigating officers noted inaccuracies in the man's story. Officers obtained consent to search the man's home and discovered what appeared to be blood stained items in the garage. The man was detained for further investigation. Detectives interviewed the man who subsequently confessed to murdering his girlfriend and then dismembering her body inside the home. The man was charged with 1st Degree Murder and Dismemberment. The case is scheduled to go to trial at the Oakland County Circuit Court in March, 2014.

MARCH 27, 2013-HOME INVASION

A resident reported that he returned home to find that the front door to his apartment had been forced open. The resident advised responding officers that a pistol and cash were missing from the home. Investigators worked with the South Oakland Narcotics Investigative Consortium (SONIC) to develop suspect information in the case. Investigators focused on a group of individuals who resided in the same building as the victim. Surveillance crews monitored the suspects' movements and arrested two (2) individuals after they were observed breaking into a home in the City of Southfield. Arresting officers recovered the stolen pistol which was in the possession of one of the suspects. The suspects were subsequently charged with Home Invasion.

MAY 7, 2013-POSSESSION OF HEROIN

Officers responded to a residence on a report of a woman who overdosed on heroin. Upon arrival, officers provided emergency medical care to the woman and spoke with her husband who admitted that he and his wife had been using heroin when she suddenly became unconscious. Paramedics transported the woman to the hospital where she later recovered. Officers learned that the man and woman lived in the

basement of the home with their four (4) year old daughter, who was also in the home during the incident. Officers searched the basement and found additional narcotics and needles just a few feet away from the daughter's bed. Oakland County Department of Human Service (DHS) was contacted and ordered temporary custody to the child's grandmother. The husband and wife were charged with possession of heroin and other illicit drugs.

MAY 20, 2013-STABBING

Officers were dispatched to a Farmington residence reference a report of a man who had been stabbed numerous times. Upon arrival, officers found an adult male laying on the floor with multiple stab wounds. The man's girlfriend admitted to officers that she stabbed her boyfriend in self-defense. Paramedics transported the man to the hospital where he later recovered from his injuries. Officers arrested the girlfriend for felonious assault. Investigators interviewed the woman who advised that she and her boyfriend began to choke her to the point where she lost consciousness. Upon regaining consciousness, she noticed that her boyfriend was assaulting her son, who was also present. In order to protect herself and her son, the woman grabbed a knife and began to stab her boyfriend. The case was presented to the Oakland County Prosecutor's Office who declined to issue charges against either party in the case.

JULY 22, 2013-HOME INVASION

A Farmington resident reported a home invasion after she noted that the rear door to her home had been forced open. The resident reported that a number of firearms, jewelry and electronics were missing from the home. During the investigation, the resident reported that he found a cell phone in the home that did not belong to him. Investigators took possession of the phone and submitted it to the Oakland County Computer Crimes Unit for forensic examination. Following the examination of the cell phone, investigators developed numerous possible suspects who may be responsible for the crime. The investigation in ongoing.

JULY 29, 2013-FATAL CRASH INVESTIGATION

An officer assigned to the midnight shift observed a minivan travelling at a high rate of

speed northbound on Farmington Road at Grand River Avenue. As the officer turned around to pursue the vehicle, he observed that the vehicle had struck a large tree along Farmington Road, south of Shiawassee. The impact tore the vehicle in half. The driver was ejected from the vehicle and was found deceased several feet away from the point of impact. The investigation revealed



that the driver was travelling in excess of 70 mph prior to the crash. Toxicology tests revealed that the driver was not under the influence of alcohol or narcotics.

MAJOR INCIDENTS

SEPTEMBER 12, 2013-1ST DEGREE CRIMINAL SEXUAL CONDUCT

Officers responded to a 911 call from a resident who advised that a female was outside of her home screaming for help. Upon arrival, officers met with the woman who advised that she had just escaped a home where she had been beaten and raped by a man with whom she had been on a date with earlier in the evening. The woman told officers that the man threatened her with a firearm during the assault. Officers set up a perimeter around the home and attempted to make contact with the male resident with negative results. Because of the threat of weapons inside the home, the department called the Oakland County Special Response Team (SRT) for assistance. SRT deputies were able to successfully order the man out of the home at which time he was taken into custody. The man was subsequently charged with numerous counts of criminal sexual conduct. The case is scheduled to go to trial in February, 2014.



Requested Action:

City Council to hold public hearing, following public hearing move to adopt resolution to vacate Third Street and Cass Street in Delos Davis Subdivision and authorize the Clerk and City Attorney to filing the necessary documents.

Background:

The Farmington City Council adopted a resolution at their March 17, 2014 regular meeting to schedule a public hearing to accept comments and questions regarding the proposed vacation of Third Street and Cass Street in the Delos Davis Subdivision. Notices were mailed to all property owners within 300 feet of the proposed street vacations and a notice was published in the Farmington Observer.

The proposed platted streets are unimproved and are not utilized as municipal streets and are not utilized by public utilities. The streets are located on the site of the Maxfield Training Center; in fact, the school building itself is located on portions of the unimproved streets, so the area has apparently never been used for street purposes. In order to provide the Farmington Public Schools with the clear title to the property, it is necessary to vacate these platted streets.

City Administration is requesting two actions on the part of the City Council. First, hold the public hearing. City Administration will provide background for the audience regarding the requested action. The City Attorney will provide additional information regarding the resolution. More importantly, he will discuss that, because Cass Street appears to be within 25 meters of the general course of a stream (Rouge River), an additional filing in Circuit Court will be necessary. Second, following the public hearing, a motion to adopt the resolution as presented. The vacation of Third Street will be complete, as far as the City is concerned, once the adopted resolution is filed with the County and the State. The vacation of Cass Street will be effective upon completion of the circuit court action and related re-platting at the State level

The Resolution cites the usual basis for the City's authority to vacate these unimproved streets, but notes that Cass Street is (or appears to be) within 25 meters of the general course of a stream. A RESOLUTION OF THE FARMINGTON CITY COUNCIL STRONGLY URGING THE MICHIGAN LEGISLATURE TO APPROPRIATE THE NECESSARY FUNDS TO REPAIR GRAND RIVER AVENUE DURING THE 2014 SEASON.

- WHEREAS, Governor Snyder signed into law legislation establishing a special appropriation in the amount of \$115 Million for repairs to highways under the jurisdiction of the Michigan Department of Transportation (MDOT); and
- WHEREAS, the Michigan Legislature will determine the allocation for this \$115 Million special appropriation; and
- WHEREAS, Grand River Avenue is an MDOT trunkline that is the primary east-west route through the City of Farmington from Halsted Road to Hawthorne Street running through Farmington's Historic District and its Downtown; and
- WHEREAS, the City of Farmington was recognized by CNN/Money Magazine as one of the top 50 small towns in America to live (#27) with Grand River Avenue playing a significant part of the City's history and charm; and
- WHEREAS, the City of Farmington has invested millions to improve its infrastructure to create a strong sense of community along with enhancing pedestrian mobility and safety in the Downtown and along Grand River; and

WHEREAS, a fully functional Grand Rive Avenue is vital to the continued success and economic growth of Farmington; and

- WHEREAS, given the collapse of Grand River, particularly between Farmington Road and Halsted, the road has created a negative impact on the City of Farmington and neighboring Farmington Hills characterized by the following:
 - 1. potholes of such large size and frequency to make motorist travel along the curb lane of Grand River unsafe to the point motorists have changed their driving patterns to avoid the potholes;
 - 2. where the condition of the road was so bad that Farmington City Administration threatened the closure of the curb lanes for the safety of motorists and pedestrians;
 - 3. chunks of asphalt blackening the yards and sidewalks of residents in historic homes significantly diminishing the enjoyment of their normally beautiful property in addition to potentially diminishing their value;
 - 4. creating a general negative perception of Farmington by those visiting for the first time; and

Resolution (ID # 1550) Meeting of April 21, 2014 WHEREAS, an application has been submitted to have a mill and overlay of Grand River Avenue from Halsted Road to Farmington Road; and

- WHEREAS, the Farmington City Council feels this is the essential short and medium term solution until the road is totally reconstructed.
- NOW, THEREFORE BE IT RESOLVED that the Farmington City Council strongly urges that the Michigan Legislature appropriate the necessary funds to mill and overlay Grand River Avenue from Halsted Road to Farmington Road during the 2014 Construction season.

Requested Action:

Move to accept receipt of the City Manager's Proposed Fiscal Year 2014-15 Budget

Background:

Pursuant to Section 8.2 of the City Charter, the City Manager is required to submit a proposed budget to the City Council on or before April 21st for the following fiscal year. The proposed budget complies with the requirements contained in the State's Uniform Accounting and Budgeting Act. The transmittal letter highlights major issues in the budget, proposed changes, projects, and future concerns.

State law requires that the adoption of the City budget millage rate be completed no more than ten days after the public hearing. City Charter requires Council to adopt the budget no later than June 21st.

The proposed budget will be delivered prior to the council meeting. The proposed budget also incorporates estimates for Fiscal Year 2015-16. A study session has been scheduled for Monday, May 5 to review the proposed budget. Following the requirements of the City Charter, Administration will be recommending that the City Council hold a public hearing regarding the millage and budget at the June 16 meeting and adopt the budget that same night.
