### **MINUTES OF PERVIOUS MEETINGS:**

Administrator Cantrell advised the Board that newly appointed City Treasurer, Christopher Weber, by virtue of his position as City Treasurer serves as a member of the Board of Trustees of the Retiree Health Care System and will complete the term of Secretary previously filled by retired Clerk/Treasurer Patsy Cantrell. Cantrell advised that the City had contracted with her to act as Administrator of the Retiree Health Care System.

# CONSIDERATION OF REALLOCATION OF \$100,000 IN PLAN ASSETS TO THE MUNDER BALANCED FUND:

MOTION by Pastue, seconded by Weber, to transfer \$100,000 in Plan assets to Munder Capital Management for investment in Munder's Asset Allocation Fund-Balanced on or before July 31, 2006. MOTION CARRIED UNANIMOUSLY.

## **CONSIDERATION OF PLAN PROCEDURES:**

Administrator Cantrell reviewed the status of policies and procedures of the Retiree Health Care System. She indicated that the Plan and Trust (System) was created by ordinance in 2002 and that development of policies and procedures was an ongoing process. Cantrell stated that the Plan is in need of revision to incorporate changes to employee benefits that have occurred subsequent to adoption of the Plan. Cantrell advised that work on policies and procedures for both the City Retirement and Retiree Health Care Systems were in progress.
